9	The State of Arizona Department of Insura	ance ("Department") received evidence that	
10	Pride Home Warranty Inc. ("PHW" or "	Respondent") offered or issued service	
11	contracts in the State of Arizona without a license. Accordingly, the Director of Insurance of		
12	the State of Arizona ("Director") makes the following Findings of Fact and Conclusions of		
13	Law and enters the following Order pursuant to A.R.S. § 20-1095.09 (B).		
14	FINDINGS OF FACT		
15	1. PHW is a Delaware domestic corporation <sup>1</sup> , file number 6811021, incorporated on or		
16	about March 22, 2018.		
17	2. PHW's last known address, as set forth in their home service agreements, is 200		
18	Continental Drive, Suite 401-729, Newark, Delaware 19713. The same address is confirmed		
19	on PHW's profile with the Better Business Bureau ("BBB").

3. The "ReviewHomeWarranties" website identifies Issac Assis as PHW's President 1 and Chief Executive Officer.<sup>2</sup> 2 3 4. According to Delaware's Division of Corporations, PHW's registered agent of record is Interstate Agent Services, LLC. The company's address as listed on PHW's filing is 501 4 5 Silverside Road, Suite 102, Wilmington, Delaware 19809. 5. PHW does not hold a permit as a service company in Arizona. 6 7 **DEPARTMENT COMPLAINTS** 8 6. On or about May 30, 2019, the Department received a complaint from Arizona 9 consumer C.V., who resides in Bullhead City, Arizona. According to C.V., she purchased a home service policy from PHW on December 26, 2018. C.V. paid \$1,080.00 for a three 10 11 year contract. 12 7. On or about December 26, 2018, C.V. received correspondence from PHW. The 13 correspondence was in regard to C.V's "new home warranty enrollment" and purchase of a "Platinum Plus" plan, under policy number 11186. 14 15 8. On or about April 22, 2019, C.V. submitted a claim to PHW because her air conditioning was not working. When PHW denied the claim, C.V. cancelled her contract. 16 17 After the cancelation, PHW refunded to C.V. a prorated amount of \$453.03 from the total 18 amount C.V. paid for the policy. 19 9. On or about June 11, 2019, the Department spoke with Morris Grant of PHW regarding C.V.'s complaint. When asked about PHW's permit (license) status in Arizona, 20 21 Mr. Grant responded, "The company is not licensed in Arizona [but] working off its 22 <sup>2</sup> https://www.reviewhomewarranties.com/pride-home-warranty-review/

Delaware license." Mr. Grant said he was unaware that PHW needed to be licensed in
 Arizona to sell policies.

3 10. The Department made a recovery of \$117.00 on behalf of C.V in addition to the
4 previously refunded amount by PHW.

5 11. On or about August 23, 2019, the Department received a complaint from an Arizona
6 consumer E.M. who resides in Surprise, Arizona. According to E.M., he purchased a home
7 service policy from PHW on March 14, 2019. E.M. paid \$449.99 for a one year contract.

8 12. On or about March 14, 2019, E.M. received correspondence from PHW. The
9 correspondence was in regard to E.M.'s "new home warranty enrollment" and purchase of a
10 "Platinum Plus" plan, policy number 11500.

13. On or about June 17, 2019, E.M. submitted a claim for his garage door. E.M
cancelled his contract after PHW denies his claim. E.M. subsequently asked PHW to
disregard his request for cancellation but was told the cancellation would not be reversed.
After the cancelation, PHW refunded to E.M. a prorated amount of \$96.00 of the total
amount E.M. paid for the policy

16 14. The Department was unsuccessful in establishing contact with an PHW
17 representative in regards to E.M.'s complaint.

1	15. According to the aforementioned "ReviewHomeWarranites" website as well as the	
2	BBB profile <sup>3</sup> , PHW is no longer in business.	
3	16. The Department's Financial Affairs Division, which reviews and processes service	
4	company permit applications, confirmed that PHW has never held an Arizona permit as a	
5	service company.	
6	CONCLUSIONS OF LAW	
7	1. Respondent's conduct, as alleged above, constitutes offering and issuing service	
8	contracts without a permit, within the meaning of A.R.S. § 20-1095.01(A).	
9	2. Service company contracts issued by the Respondent are enforceable and valid	
10	contracts, within the meaning of A.R.S. § 20-1095.05	
11	3. Grounds exist for the Director to order Respondent to cease and desist its violations	
12	pursuant to A.R.S. § 20-1095.09(B).	
13	ORDER	
14	IT IS HEREBY ORDERED THAT:	
15	1. Respondent shall immediately cease and desist from unlawfully offering or	
16	issuing service contracts in the State of Arizona.	
17	NOTICE OF OPPORTUNITY FOR HEARING	
18	Pursuant to Title 20 of the Arizona Revised Statutes, Respondent is hereby notified	
19	that it may request a hearing pursuant to A.R.S. § 20-161 to contest the order to cease and	
20	desist.
