Based upon reliable evidence provided to the Director of Insurance by the Assistant Director of the Financial Affairs Division of the Arizona Department of Insurance and Financial Institutions ("Department"), the Director finds as follows:

FINDINGS OF FACT

- 1. Respondent, American Service Insurance Company, Inc. is an Illinois domiciled property and casualty insurer initially granted authority to transact property and casualty insurance business on September 22, 2004.
- 2. On September 4, 2020, the Director issued an order suspending the certificate of authority of Respondent based upon Respondent's failure to meet the requirements for the authority originally granted to it within the meaning of Arizona Revised Statutes ("A.R.S.") §20-219(2).
- 3. Respondent filed an application for reinstatement on November 11, 2021 and has corrected all deficiencies and meets the requirements for the authority to transact insurance within the meaning of A.R.S. Title 20.
- 4. Respondent is current in regard to all filings and fees required to be made to the Department and owes no outstanding fines and penalties.

CONCLUSIONS OF LAW 1 1. The Director has jurisdiction over this matter. 2 2. Respondent is no longer in unsound financial condition or in such condition as to 3 render the further transaction of insurance in this State hazardous to its policyholders or to the 4 5 people of this State within the meaning of A.R.S. §20-220(A)(3). 3. 6 Respondent's business operations are in apparent compliance with all applicable provisions of Arizona Revised Statutes Title 20 and grounds exist for the Director to reinstate 7 the Respondent's certificate of authority. 8 9 ORDER The September 4, 2020 Order is vacated and Respondent's certificate of authority is 10 reinstated effective this date. 11 Effective this 26th day of September , 2022. 12 13 14 EVAN G.
