Based upon reliable evidence provided to the Director of Insurance and Financial Institutions by the Assistant Director of the Financial Affairs Division of the Arizona Department of Insurance and Financial Institutions ("Department"), the Director finds as follows:

## FINDINGS OF FACT

- 1. Lincoln Life Assurance Company of Boston ("Petitioner") is a New Hampshire domiciled insurance company that received its certificate of authority to transact life and disability insurance in Arizona effective November 20, 1968.
- 2. Effective October 1, 2021, Petitioner, the non-surviving entity, merged into The Lincoln National Life Insurance Company (LNLIC), NAIC No. 65676, an Indiana domiciled insurer and the surviving entity. LNLIC is authorized to transact insurance in Arizona. Petitioner voluntarily surrendered its certificate of authority to the Department.
- 3. The Insurance Commissioner of New Hampshire approved the merger of Petitioner into LNLIC on August 11, 2020.
