This matter having been duly noticed for hearing on the 22nd day of October, 1987, before the Director of Insurance or his duly designated representative; the Department being represented by Sara Morrissey-Begley, Esq., Assistant Attorney General, and the Respondent not appearing either in person or through counsel; testimony having been received and documentary evidence having been admitted, the Director finds as follows:

FINDING OF FACTS

1. Notice is proper in this case pursuant to A.R.S. §§41-1009 & 41-1013;
2. Jurisdiction is proper for this hearing pursuant to A.R.S. §41-1013;
3. At all times relevant hereto, Respondent was a licensed insurance agent with the State of Arizona;
4. In 1986, Respondent was convicted of four counts of aggravated assault, class 3 felonies, and five counts of endangerment, class 6 felonies;
5. On or about December, 1986, Respondent was sentenced by the Mohave County Superior Court, under cause number CR-8287, to 6 years on one count and 5 years on three counts of aggravated assault, with all aggravated assault counts to run concurrently, 1 1/2 years for each of the five counts of

1 endangerment, with sentencing for the endangerment counts to
2 begin at the completion of the 6 years aggravated assault
3 sentence, and was fined \$500.00.

4 CONCLUSIONS OF LAW


5 1. The herein-described conduct constitutes a record
6 of conviction by final judgment of felonies involving moral
7 turpitude within the meaning of A.R.S. §20-316.A.6.


8 IT IS, THEREFORE, ORDERED:

9 1. That Respondent's license to transact insurance in
10 the State of Arizona is hereby REVOKED;

11 2. Respondent may request a rehearing with respect to
12 this Order by filing a written petition with the Director within
13 30 days of the date of this Order, setting forth the basis for
14 such relief pursuant to A.R.S. §41-1010(B), and A.C.R.R. R4-14-
15 159.
