ORDER

Based upon reliable evidence provided to the Director of Insurance by the Assistant Director of the Corporate and Financial Affairs Division of the Department of Insurance, the Director finds as follows:

1. Petitioner, The Home Insurance Company of Wisconsin, NAIC No. 40363, is a foreign insurer currently domiciled in New Hampshire. Petitioner received its certificate of authority to transact property and casualty insurance in Arizona on May 31, 1989.

2. Effective June 14, 1996, Petitioner, the non-surviving entity, merged into The Home Insurance Company ("Home"), the surviving entity, a foreign insurer domiciled in New Hampshire. Petitioner has voluntarily surrendered its certificate of authority to the Director.

3. On May 30, 1996, the Insurance Commissioner of New Hampshire approved the merger of Petitioner into Home.

4. Petitioner has no obligations under any policy of insurance to any policyholders or claimants who are residents of Arizona.

1 5. Petitioner is not the subject of any pending  
2 investigation or market conduct examination, and Petitioner does  
3 not owe this Department any filings or fees.


4 6. Petitioner has deposited \$100.00 which has been  
5 credited to the Insurance Examiners' Revolving Fund ("IERF")  
6 pursuant to A.R.S. §20-159.

7 IT IS ORDERED that:

8 1. The surrender of the Petitioner's certificate of  
9 authority is accepted.

10 2. The \$100.00 deposited by Petitioner which has been  
11 credited to the IERF shall be released to Petitioner.
