Respondent.	)	<b>FINDINGS OF FACT, CONCLUSIONS OF LAW, AND ORDER</b>

On May 1, 1997, the Director issued an Order Summarily Suspending License and Notice of Hearing ("Notice") in the above-captioned matter, a copy of which is attached and incorporated by this reference. The Notice required Richard James Baggs to provide a written answer to the allegations set forth in the Notice within twenty days of the issuance of the Notice. As of this date, Respondent has failed to file an answer. On June 12, 1997, counsel for the Department filed a Request for Default, and proposed Findings of Fact, Conclusions of Law and Order. As of this date, Respondent has not responded to the Department's request. Pursuant to A.A.C. R20-6-106(C), a party that fails to file an answer within the time provided shall be deemed to be in default and one or more of the allegations in the notice of hearing may be deemed to be admitted.

**FINDINGS OF FACT**

1. Notice was proper.
2. Richard James Baggs is in default.
3. The allegations in the Notice are deemed admitted.

**CONCLUSIONS OF LAW**


1. The conduct alleged in the Notice constitutes grounds for the Director to suspend, revoke or refuse to renew Respondent's license to transact insurance in Arizona, pursuant to A.R.S. §20-316(A).

Respondent.	)	LICENSE AND NOTICE OF HEARING

The Arizona Department of Insurance (the "Department") alleges that Richard James Baggs, the Respondent, has violated the provisions of A.R.S. Title 20. In light of the serious nature of these allegations, the Director of Insurance ("Director") finds that the public health, safety and welfare imperatively requires emergency action, within the meaning of A.R.S. § 41-1064(C).

THEREFORE, IT IS ORDERED summarily suspending Respondent's Arizona insurance license, effective immediately, pending the proceedings commenced this date.

PLEASE TAKE NOTICE that pursuant to the provisions of Arizona Revised Statutes ("A.R.S.") §§ 20-161 through and including 20-165, 41-1061 through and including 41-1066 and 41-1092.01, the above-captioned matter will be heard before the Director of Insurance of the State of Arizona (the "Director"), or his duly designated representative, on the 23<sup>rd</sup> day of June,

1 1997, at 9:00 a.m., at Office of Administrative Hearings, 1700  
2 West Washington Street, Capitol Tower, West Wing, Suite 602,  
3 Phoenix, Arizona (the "Hearing").

4 Motions to continue this matter shall be made in writing to  
5 the Administrative Law Judge not less than five (5) business days  
6 prior to the date set for the hearing. A copy of any motion to  
7 continue shall be mailed or hand-delivered to the opposing party  
8 on the same date of filing with the Office of Administrative  
9 Hearings.

10 A.R.S. § 20-164 entitles any person affected by this Hearing  
11 to appear in person and by counsel, to be present during the  
12 giving of all evidence, to have a reasonable opportunity to  
13 inspect all documentary evidence, to examine witnesses, to present  
14 evidence in support of his/her interests, and to have subpoenas  
15 issued by the Administrative Law Judge to compel attendance of  
16 witnesses and production of evidence on the person's behalf.

21 NOTICE OF APPLICABLE RULES

22 On January 23, 1992, the Arizona Department of Insurance  
23 adopted A.A.C. R20-6-101 through R20-6-115, setting forth the  
24 rules of practice and procedure applicable in contested cases  
25 before the Director of Insurance. The hearing will be conducted  
26 pursuant to these rules.

1 PURSUANT TO A.A.C. R20-6-106, RESPONDENT SHALL FILE A WRITTEN  
2 ANSWER WITHIN 20 DAYS AFTER ISSUANCE OF THIS NOTICE OF HEARING AND  
3 SHALL MAIL OR DELIVER A COPY OF THE ANSWER TO THE ASSISTANT  
4 ATTORNEY GENERAL DESIGNATED ABOVE. THE ANSWER SHALL STATE  
5 RESPONDENT'S POSITION OR DEFENSE AND SHALL SPECIFICALLY ADMIT OR  
6 DENY EACH ASSERTION IN THE NOTICE OF HEARING. ANY ASSERTION NOT  
7 DENIED SHALL BE DEEMED TO BE ADMITTED. ANY DEFENSE NOT RAISED IN  
8 ANSWER SHALL BE DEEMED WAIVED. IF AN ANSWER IS NOT TIMELY FILED,  
9 RESPONDENT SHALL BE DEEMED IN DEFAULT AND THE DIRECTOR MAY DEEM  
10 THE ALLEGATIONS ARE TRUE, AND TAKE WHATEVER ACTION IS APPROPRIATE,  
11 INCLUDING SUSPENSION, REVOCATION, DENIAL OF A LICENSE, OR RENEWAL  
12 OF A LICENSE, IMPOSITION OF A CIVIL PENALTY AND/OR ORDER  
13 RESTITUTION TO ANY PARTY INJURED.

14 PERSONS WITH DISABILITIES MAY REQUEST REASONABLE  
15 ACCOMMODATIONS SUCH AS INTERPRETERS, ALTERNATIVE FORMATS, OR  
16 ASSISTANCE WITH PHYSICAL ACCESSIBILITY. REQUESTS FOR  
17 ACCOMMODATIONS SHOULD BE MADE AS EARLY AS POSSIBLE TO ALLOW TIME  
18 TO ARRANGE THE ACCOMMODATIONS. IF YOU REQUIRE ACCOMMODATIONS,  
19 PLEASE CONTACT THE OFFICE OF ADMINISTRATIVE HEARINGS AT 542-9826.

20 The Department alleges:

21 1. Respondent Richard James Baggs ("Respondent") currently  
22 holds license number 33585 to transact business as a life and  
23 disability insurance agent. That license is due to expire  
24 September 30, 1997.

25 2. On or about October 22, 1996, the Pima County Superior  
26 Court entered a Judgment in State of Arizona v. Richard James

1 Baggs, Case No. CR-54091, convicting Respondent of Theft by  
2 Conversion, a Class 4 Felony, in violation of A.R.S. § 13-  
3 1802(A)(2) and (C). The Court suspended imposition of sentence  
4 and placed Respondent on four years supervised probation. The  
5 Court also ordered Respondent to pay restitution in the amount of  
6 \$132,021.00 to Great Western Insurance Company at a rate of \$150  
7 per month commencing December 1, 1996.

8 3. Respondent has a record of dishonesty in business or  
9 financial matters in violation of A.R.S. § 20-316(A)(1) together  
10 with A.R.S. § 20-290 (B)(2).

11 4. Respondent's conduct alleged above constitutes a wilful  
12 violation of, or a wilful noncompliance with, any provision of  
13 this title, or any lawful rule, regulation or order of the  
14 director, in violation of A.R.S. § 20-316(A)(2).

15 5. Respondent's conduct and actions constitute the  
16 misappropriation or conversion to his own use or illegal  
17 withholding of monies belonging to policyholders, insurers,  
18 beneficiaries or others and received in or during the conduct of  
19 business under the license or through its use, in violation of  
20 A.R.S. § 20-316(A)(4).

21 6. Respondent's conduct alleged above constitutes a  
22 conviction by final judgment of a felony involving moral  
23 turpitude, in violation of A.R.S. § 20-316(A)(6).

24 7. Respondent's conduct and actions constitute a conduct  
25 of affairs under the license, showing the licensee to be  
26 incompetent or a source of injury and loss to, or repeated

1 complaint by, the public or any insurer, within the meaning of  
2 A.R.S. § 20-316(A)(7).

3       Grounds exist for the Director to suspend, revoke or refuse  
4 to renew Respondent's insurance license, impose a civil penalty  
5 upon Respondent and/or order restitution, pursuant to A.R.S. § 20-  
6 316(A) and 20-316(C).

7       WHEREFORE, if after hearing, the Director finds the grounds  
8 alleged above, the Director may suspend, revoke or refuse to renew  
9 Respondent's insurance license or order restitution, pursuant to  
10 A.R.S. § 20-316(A) and 20-316(C).

11       Pursuant to A.R.S. § 20-150, the Director of Insurance  
12 delegates the authority vested in the Director of Insurance of the  
13 State of Arizona, whether implied or expressed, to the Director of  
14 the Office of Administrative Hearings or his designee to preside  
15 over the hearing of this matter as the Administrative Law Judge,  
16 to make written recommendations to the Director of Insurance  
17 consisting of proposed findings of fact, proposed conclusions of  
18 law, and a proposed order. This delegation does not include  
19 delegation of the authority of the Director of Insurance to make  
20 the order on hearing or other final decision in this matter.

21       Pursuant to A.R.S. § 41-1092.01, your hearing will be  
22 conducted through the Office of Administrative Hearings, an  
23 independent agency. Enclosed is a copy of the procedures to be  
24 followed.


