Based upon reliable evidence provided to the Director of Insurance by the Assistant Director of the Corporate and Financial Affairs Division of the Department of Insurance, the Director finds as follows:

1. Petitioner, Pacific Corinthian Life Insurance Company, NAIC No. 88881, is a foreign insurer domiciled in California. Petitioner received its certificate of authority to transact life insurance in Arizona on May 3, 1993.

2. Effective October 30, 1997, Petitioner, the non-surviving entity, merged into Pacific Life Insurance Company ("Pacific"), the surviving entity, a foreign insurer domiciled in California. Petitioner has voluntarily surrendered its certificate of authority to the Director.

3. On July 1, 1992, the Insurance Commissioner of California approved the merger of Petitioner into Pacific.

4. Petitioner has no obligations under any policy of insurance to any policyholders or claimants who are residents of Arizona.

1 5. Petitioner is not the subject of any pending
2 investigation or market conduct examination, and Petitioner does
3 not owe this Department any filings or fees.


4 6. Petitioner has deposited \$100.00 which has been
5 credited to the Insurance Examiners' Revolving Fund ("IERF")
6 pursuant to A.R.S. §20-159.

7 IT IS ORDERED that:

8 1. The surrender of the Petitioner's certificate of
9 authority is accepted.

10 2. The \$100.00 deposited by Petitioner which has been
11 credited to the IERF shall be released to Petitioner.
